**On Amendments to the Federal Law “On the Legal Status of Foreign Citizens in the Russian Federation” regarding the simplification of the procedure for employment in the Russian Federation of students of Russian professional and higher education institutions for foreign citizens and stateless persons**

Adopted by the State Duma on January 23, 2020

Approved by the Federation Council on January 30, 2020

**Article 1**

1) in article 13:

a) paragraph 4 shall be supplemented with subparagraph 7<sup>1 as</sup> follows:

"7<sup>1</sup>) of full-time students in the Russian Federation in professional educational organizations and educational institutions of higher education under the main professional educational program, which has state accreditation, and who work in their free time";

b) recognize subparagraph 4 of paragraph 4<sup>5</sup> as null and void;

c) in subparagraph 1 of paragraph 6, the words ", and in the event that a foreign citizen engages in labor activities in the manner prescribed by Article 13<sup>4</sup> of this Federal Law, shall be excluded outside the subject of the Russian Federation on the territory of which this foreign citizen is studying";

d) add paragraph 8<sup>1</sup> to read as follows:

"8<sup>1</sup>. In the event that a foreign citizen has completed or stopped studying at a professional educational institution or educational institution of higher education, an employment contract or a civil law contract for the performance of work (provision of services) concluded with a foreign citizen shall be terminated.";

2) Article 13<sup>4</sup> shall be declared invalid;

3) in clause 6 of Article 15<sup>1</sup>, the words "as well as foreign citizens studying in the Russian Federation on full-time studies at professional educational organizations or educational organizations of higher education under state accredited basic professional educational programs and carrying out labor activities in accordance with Article 13<sup>4</sup> of this Federal Law "to exclude;

4) in article 18:

a) in paragraph 8:

in subparagraph 3 the words "with the exception of the case provided for in Article 13<sup>4</sup> of this Federal Law" shall be deleted;

in subparagraph 5 the words "with the exception of the case provided for in Article 13<sup>4</sup> of this Federal Law" shall be deleted;

b) Clause 9<sup>6</sup> shall be declared invalid.

## Section 2

This Federal Law shall enter into force one hundred eighty days after the day of its official publication.
